General Trial Information:

There will not be any Friday evening exhibitor setup!!

The building will open at 7:00 am both days

- No one, other than Doggie U Staff and Trial Committee members are allowed to enter the building before 7 AM

Measuring

- **7:20-7:40 both Saturday and Sunday**
- **Not many dogs need measuring each day, so there won't be a big line or wait.**
- **There will be no measuring after the briefings begin. If your dog needs to be measured, and if you don't get it done before the briefing, you won't be able to run.**

The dogs that need to be measured are: Lexi Buscareno, Annie Frohman, Bridget Gallager, Piece Kraft, Carly Russo, Sully Saunders, Quiz Simonelli and Rush Washburn.

Judging Time

- **8:00 both Saturday and Sunday**

We are running Tall to Small on Saturday and Small to Tall on Sunday. Please refer to the catalog for the actual running order.

General Site Information:

Doggie U is an indoor site with heat and air conditioning and the running surface is rubber matting.

The Doggie U parking lot and building will open **at 7 AM Saturday/Sunday.**

Parking: There is no general exhibitor parking in the small lot immediately in front of the building, or in front of the bay doors and dumpster PLEASE OBSERVE SIGNS FOR RESERVED SPACES. Parking is allowed in front of and around the MasterCraft building as well as in the front section of CMS across from Doggie U. Street parking is also allowed. We suggest that you do not park north of the Doggie U Site. The building just north has a guard dog so we prefer to avoid this area. There is NO RV / Camper or overnight parking availability. We will set up a loading area at the curb in front of the building (don't come in the lot), for about the first hour each morning.

Potty area: Is the grassy strip in front of the building, plus there is a pebble stone potty area located in the front loading bay behind the dumpster. The well-kept grassy areas across the street from our building are completely Off LIMITS.

Crating: Crating space is VERY limited. We will have crating in the lobby and in a small “crating” room off the lobby. **We only have room for a few x-pens, either metal or soft-sided, and if you absolutely need an x-pen because you have multiple large dogs, the space must be reserved in advance by contacting Louise Wetzel at dragondogs4@nyc.rr.com. Only exhibitors who have made arrangements with Louise will be allowed to set up x-pens.** All dogs must be crated, and you should be prepared to stack your crates. If you bring a dog that is not entered, that crate must be stacked on another so as not to take up floor space. “

If weather permits we may open the overheard door to allow for outside crating with access.

Doggie U House Rules:

- Potty your dogs in the designated potty area ONLY.
- ALWAYS PICK UP AFTER YOUR DOG!!
- No dogs off leash at any time other than in the ring or at the practice jump.
- No squeaky toys or clickers are allowed in the building.
- **NO FOOD OR DRINK, OTHER THAN WATER, IS ALLOWED IN THE RING ROOM AT ANY TIME!**

Directions:

From Southern State Pkwy, take exit 42 South, 5th Ave. Bay Shore. Stay to the left, make a left at the light onto 5th Ave, *turn left onto Spur Dr. North, (there is a McDonalds on the corner), take first right onto 5th Industrial Court. Doggie U is on the left, and you’ll see a sign for “Master Concepts”, which is in the same building. Spur Drive North is just slightly north of Southern State Parkway.

From Sunrise Hwy take exit 43 North, 5th Ave., then follow from *.

From the LIE, take exit 53, Sagtikos Pkwy, to Southern State Pkwy East, exit 42 North, then follow from *. (Alternate route for commercial or large vehicles, LIE exit 53 (same exit as Sagtikos Pkwy) to Wicks Rd. Travel for 3.8 miles south on Wicks Rd, which becomes 5th Ave, then right on Spur Dr. North, right onto 5th Industrial Court.)
