

Congratulations, you're entered in the above Teacup Dog Agility Association agility trial hosted by Doggie U K9 Academy.

This is your Trial Information letter. You have already received your entry information, please review it and notify me by email or mail immediately of any changes or modifications that need to be made.

General Site Information:

Doggie U is an indoor site with heat and air conditioning and the running surface is rubber matting.

Parking: Is in front of Doggie U as well as in front and around the MasterCraft building. Street parking is also allowed. **THERE IS NO LONGER ANY PARKING ALLOWED IN THE LOT ACROSS FROM DOGGIE U! YOU WILL BE TOWED!!** There is NO RV / Camper or overnight parking availability.

Food: In keeping with our current Teacup tradition, we will be having our "Pot Luck" Food Fest again. Please bring your favorite dish for all to share.. A Google doc has been set for everyone to fill out what they plan on bringing. This will help others to decide what to bring also. Around 20 people are expected to be at the trial. Potty area: Is the grassy strip in front of the building as well as the gravel area in front of the loading dock. The well-kept grassy areas across the street from the building are completely Off LIMITS.

Doggie U House Rules:

- Potty your dogs in the designated potty area ONLY.
- ALWAYS PICK UP AFTER YOUR DOG!!
- No dogs off leash at any time other than in the ring or at the practice jump.

Directions:

From Southern State Pkwy, take exit 42 North, 5th Ave. Bay Shore. Merge immediately to the left, onto 5th Ave, *turn left onto Spur Dr. North, (there is a McDonalds on the corner), take first right onto 5th Industrial Court. Doggie U is on the left, and you'll see a sign for "Master Concepts", which is in the same building. Spur Drive North is just slightly north of Southern State Parkway.

From Sunrise Hwy take exit 43 North, 5th Ave., then follow from *.

From the LIE, take exit 53, Sagtikos Pkwy, to Southern State Pkwy East, exit 42 North, then follow from *. (Alternate route for commercial or large vehicles, LIE exit 53 (same exit as Sagtikos Pkwy) to Wicks Rd. Travel for 3.8 miles south on Wicks Rd, which becomes 5th Ave, then right on Spur Dr. North, right onto 5th Industrial Court.)

General Trial Information:

There is NO setup prior to Sunday morning – Since this is such a small trial, we don't need to setup the night before. The building will be open at 7:00 am on Sunday morning for setup.

The Teacup trial setup will be contained entirely within the main agility area. We will have a crating area set up just outside the ring.

Timeline:

- The doors to Doggie U will open at 7:00 am on Sunday.
- Measuring will start at 7:30am
- Judging will start at 8:00 am.

Practice Jump:

A practice jump will be available for dogs to warm up before their run.

Measuring:

Does your dog need to be measured? TDAA requires two measurements. If this is your first TDAA trial then **YES** your dog needs to be measured. If you were at the last Doggie U TDAA trial and have one measurement, then **YES** your dog needs to be measured. *** Note – TDAA sends out a height certificate to your email address. They do NOT send out “height cards” like other venues. If you are un-sure if you received this document, you can email TDAA and they will advise you. **If your dog needs to be measured** please fill out the measurement form in advance and have it ready for the judge to sign when he or she measures your dog.

Running Orders:

Running orders will **not** be posted in advance of the trial. This is a very small trial with only 18-25 dogs per entire class, so you need to be there and ready when the class starts. If you are running multiple dogs, I will do my best to separate your runs as much as possible. If this does not leave you enough time, we will accommodate you the day of the trial.

Time and Score (All levels), Standard rounds 1 & 2, (BB, II, SS), Fullhouse (All levels), Barrel Racing (All levels)

** Where B = Beginner, I = Intermediate and S = Superior

Move Ups:

Move ups are available from run to run. **HOWEVER**, Once we start a round of a Class (NOT level), we cannot process a move-up that round without having to re-score the entire round. Example, Standard R2 for ALL levels, counts as starting that round.
